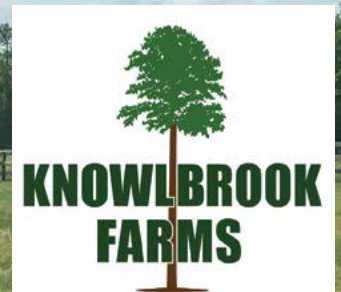

2025 NCHJA Show General Rules & Regulations



This show is a regular member of the United States Equestrian Federation. Every class offered herein is covered by the rules and specifications of the current USEF rule book and will be conducted and judged in accordance therewith.

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) assistant handlers in Dressage Sport Horse Breeding classes

REMINDER: All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF SafeSport Policy, and the Minor Athlete Abuse Prevention Policies. More information about these can be found at www.usef.org.

The Horse Show Committee reserves the right to interpret all questions and conditions in regard to or arising out of, or incident to the show without claims for damages or recourse of any kind. All questions not covered in these Rules and Regulations shall be decided by the Horse Show Management; its decision to be final. The Horse Show Management reserves the right to limit entries in any class, section or division, to refuse, accept conditionally, or to cancel any entries, disqualify any riders or exhibitors, prohibit exhibition of entries, and cancel award prizes, without any claim for damages; to change any course, to add a dotted line, to cancel or combine any unfilled classes, or to reschedule classes, after due notice to exhibitors; to change rings or rotate judges; to change specifications in jumper classes as competition warrants. Every horse entered herein for competition will be under the control of the Horse Show Management, but the Show Management will in no case be responsible for any loss or damage that may occur, and it shall be a condition of entry that each exhibitor shall hold the horse show and the officials, employees, directors, officers, sponsoring entities of the horse show and the facilities at which the horse show is held harmless for any loss or accident to his horse(s), employee(s), or equipment which may occur from sickness, fire or other cause. Each horse entered for competition will be assessed a USEF Federation Fee of \$23 (\$8 Drug and Medication/\$15 USEF) and a \$7 USHJA fee. While every effort has been made to avoid mistakes in this publication, the USEF, the NCHJA and its management assume no liability to anyone for errors. Any significant errors or changes will be disclosed to competitors whose entries are accepted upon their acceptance, and otherwise in accordance with USEF rules.

ENTRIES: Entries close June 15, 2025. New entries (new or different horses) made after these dates will incur a one time late fee of \$50.00. All entries must be done online. No "day of" entries will be accepted. Every Entry Blank must have the signature of the owner/authorized agent, trainer & be accompanied by an open check or valid credit card information. It is the responsibility of the person making the entry to execute properly and complete all necessary information pertaining to each entry made in accordance with USEF rules. USEF has required that all participants, trainers, crew, staff, and officials must sign the new mandatory waiver. **THIS MUST BE DONE.** Please fill them out, however unlike entry forms, the new waiver must be signed by each party! This means the trainer cannot sign for Owners or Riders. **NO NUMBERS WILL BE ISSUED WITHOUT AN OPEN CHECK OR VALID CREDIT CARD INFORMATION.** There will be a \$50.00 office/services fee for every horse on the show grounds. Management reserves the right to refuse any entry for any reason.

NON-NEGOTIABLE CHECKS: A \$50.00 SERVICE FEE OR 10% OF THE CHECK AMOUNT/CREDIT CARD CHARGE, WHICHEVER IS GREATER, WILL BE CHARGED FOR ALL RETURNED CHECKS AND/OR DECLINED CREDIT CARDS. Accounts that are not settled within five days with certified funds will be reported to USEF in accordance with USEF Rules.

SETTLEMENT OF ACCOUNTS: All show accounts must be closed out at the end of the week. Any open entry accounts will be closed by management and a \$50 processing fee will be added per entry. Any mistakes or questions regarding your horse show account and/or prize money must be resolved within 24 hours by contacting the Horse Show Office.

REFUNDS: STALL FEES CANNOT BE REFUNDED AFTER MAY 20, 2025. Entry fees will not be refunded unless a certificate of illness or injury prepared by an accredited veterinarian, or a doctor's note regarding rider illness/injury, is presented to the secretary before the start of the show. Once the show has started, proper notification of the scratch must be made in the office BEFORE the start of the classes being scratched. In either case the entry fees will be refunded less any nominating fees, stall fee, and an office processing charge of \$75.00.

Horses, on the grounds, not entered in any classes, must have a completed entry

blank on file in the office and will be charged a \$75 non-showing fee per week. Horses not accruing a minimum of \$100 in entry fees may be charged the non-showing fee in lieu of entry fees.

* **Warning:** Horses that compete in a class in which they are not properly entered will be charged a double entry fee. Once a horse has competed in the first class of a Premier AA rated hunter section, the division entry fee cannot be refunded.

* **Attention foreign exhibitors:** All fees MUST be paid in "US Funds".

STALLS: There are 192 permanent stalls 11' x 12' with interlocking mats and screen doors. There are 250 temporary stalls 10' x 10' with doors on grass under canvas cover. Initial bedding will not be provided and can be ordered online on the Stable Master website at www.stallinfo.net. Once the show begins, all hay and bedding can be ordered online at www.stallinfo.net. Stalls, whether occupied by horse, feed, or tack will not be available until Monday, June 23, 2025 after 12:00 noon. The last day to request stall refunds is May 20, 2025.

GENERAL RULES AND INFORMATION

CREDENTIALS: ALL EXHIBITORS IN ANY PONY, PONY EQUITATION, JUNIOR HUNTER OR AMATEUR SECTION MUST PRESENT THEIR CREDENTIALS (MEASUREMENT CARD OR AMATEUR CERTIFICATION) TO THE SHOW OFFICE BEFORE THEIR NUMBERS CAN BE RELEASED. Kindly send a photo copy of credentials with entry to facilitate processing. All horses or ponies without a valid measurement card will be measured at a designated time and place. Anyone not presenting valid membership credentials (USEF/USHJA) will have to fill out a USEF/USHJA Show Pass form and will be charged a \$30.00 non-refundable show pass fee for USHJA and \$45.00 non-refundable show pass fee for USEF. Amateur exhibitors must present valid Amateur Credentials. Only a parent will be exempt from the Federation non-member fee if signing as coach for his/her minor child.

HORSE REGISTRATIONS: All horses competing in Federation non-breed restricted licensed competitions with hunter, hunter breeding, jumper and hunter seat equitation classes (except those activities enumerated in GR901.9, items 1-9) must be properly identified and must obtain a Registration Number from USHJA. A registration number for each horse must be entered on all entry forms for licensed competitions. Proof of registration must be presented to the Show Secretary before numbers can be released. To be eligible for National, Regional or Zone Horse of the Year Awards, and to enter a USEF Computer Ranking List Class horses must also be registered with the USEF. Exception for USEF Computer Ranking List: Citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation need not have USEF Registration.

USEF/USHJA FEES: Current USEF rules relating to drugs and medications will be enforced. Each horse entered must pay the \$15.00 USEF Drug/Medication Fee plus an \$8.00 USEF fee. Each horse entered will also be required to pay the USHJA Fee of \$70.00. (Total USEF/USHJA Fees \$30.00).

ADDS/SCRATCHES: ALL ADDS MUST BE COMPLETED ON HORSESHOWSONLINE.COM NO LATER THAN 5:00pm THE DAY PRIOR TO THE CLASS. No Same Day Adds will be accepted. Scratches will be accepted at any time prior to the start of the class - Scratch Fee may apply. Any scratches in the Derby after 5:00pm the night prior to the Class will incur a \$35 Scratch Fee.

HORSE/PONY MEASUREMENTS: Please advise the show office of any horses and/or ponies requiring measurement. Any horse/pony that cannot present a valid measurement card will be required to present themselves for measurement at the time/times posted in the show office.

SCHOOLING: Hunter Rings will be open for schooling on the day prior to the show. RIDERS MUST HAVE A NUMBER AT ALL TIMES WHEN MOUNTED. Time permitting, rings may also be open before and after the show, each day, for hacking, times to be posted or announced. No manual poling; no offsets of any type may be used while schooling. Jumping will be permitted, in the rings, at scheduled times and only when medical personnel are on the grounds.

HARD HATS MUST BE WORN AT ALL TIMES WHILE MOUNTED

ANIMAL WELFARE: We require that all horses be treated with kindness, respect and compassion and should never be subject to mistreatment. Owners, trainers, riders and grooms, or their agents must use reasonable care in the handling and treatment of their horses whether owned or placed in their care for competition or for any other purpose. At all times, while the horse is on the show grounds, we will provide for the continuous well-being of the horse by vigorously enforcing the rules of the USEF which pertain to the welfare of the horse. USEF rules defining policy regarding abuse and use of whips will be strictly enforced. No poling, use of bamboo off-set or excessive use of the whip will be tolerated. The well being of the horse must be considered above the demands of the breeders, trainers, riders, owners, dealers, organizers, sponsors or officials. Violators may be subject to penalties pursuant to USEF rules. In the event of an acute and serious injury to or illness of a horse on competition grounds when the owner or trainer of the horse or agent of the owner is not present, after reasonable effort to contact that individual has been made, competition management, in consultation with a licensed equine veterinarian, may

authorize the provision of emergency veterinary treatment of the horse. If competition management so authorizes treatment under the provisions of this rule, competition management and veterinarian are not liable for any resulting costs, damages, losses, claims or actions arising directly or indirectly from the treatment of the horse.

DOGS: There will be a Zero Tolerance Policy for Loose Dogs. All dogs must be restrained at all times while on the show grounds. Unrestrained dogs create a serious safety hazard for exhibitors and their horses. The dogs will be impounded and the owner charged \$100 that will be donated to the Humane Society. The owner of any dog that disrupts a Competitor's round in the ring will be required to reimburse said Competitor for their entry fees including the entire division fee. USEF GR 1301.6: Dogs are not permitted to be loose on competition grounds and must be held on a leash or otherwise restrained. Individuals must not lead dogs on a leash while mounted. Dog owners are solely responsible for any damages, claims, losses or actions resulting from their dogs' behaviors. Dog owners failing to comply with this rule will be issued a Yellow warning card may be subject to penalty under Chapters 6 and 7.

CHANGES: Management reserves the right to change, cancel, or combine classes, alter courses and do all things necessary to compensate for excessive or inadequate entries.

ATTIRE/HEADGEAR: Formal Attire:

Hunters: Riders are required to wear scarlet or dark coats; white shirts with white stock; white, buff or canary breeches. Members of the Armed Services or the Police may wear the Service Dress Uniform. **Equitation:** Riders are required to wear conservatively colored coats (black, blue, green, grey or brown) which are free from adornment which in the judge's opinion is overly distracting. Shirts must have a choker, similar collar or tie. Breeches may be buff, canary, tan, rust or white. **Jumpers:** Dark, muted or similar colored, or red (scarlet) coats are required; team or sponsored coats of different colors are also permitted; white or fawn breeches; a white tie, choker (unless the shirt, by design, has the choker built in for its intended use) or hunting stock, and a white or lightly colored shirt must be worn. Shirts must have a white collar and white cuffs. Shirts must be fastened at the neck and tucked into breeches. Boots are required. Half chaps are permitted as long as the color matches the paddock boots being worn. Members of the Armed Services or the police may wear the service dress uniform with protective headgear. (See General Rules, GR801.2)

Numbers must be worn and clearly visible. Protective head gear must be worn **BY ALL RIDERS AT ALL TIMES WHILE MOUNTED**, anywhere, anytime on the show grounds. Headgear for all riders must meet or exceed ASTM Standards; must carry the SEI tag; and be properly secured by a harness.

JUMPERS: Ties in jumper classes will jump off for first place only. Ties for all other places will be determined by first round time. Champion and Reserve will be determined using the USEF Bonus Point system. Bonus Points will apply to the class indicated for each section.

NOMINATING FEE: To be eligible for all Jumper divisions except Children's/ Adult and Training classes, horses must be nominated and pay the nominating fee of \$150/\$160.

FOOTING/RING SIZE: Footing is a clay, sand, screenings mix.

Ring 1 - 198' x 292' synthetic footing

Ring 2 - 200' x 350' sand footing

Ring 3 - 165' x 220' synthetic footing

Ring 4 - 165' x 220' synthetic footing

Ring 5 - 220' x 500' sand footing

Derby Field - Open - gentle rolling terrain, sandy loam soil under grass

LUNGING: There should be no lunging in the show rings at any time. All lunging should be in specified areas.

JUMP ORDER: Show Management will determine a rotating jump order for all classes over fences. Riders or Trainers with conflicts must see the paddock masters in both rings so that the necessary adjustments can be made. Starters have the authority to scratch entries that make no attempt to be timely, without going through the Steward or Show Manager.

COURSES: Courses will be posted a minimum of one hour prior to each class. In Hunter classes, fences will simulate fences found in the hunt field such as; brush, wall, in & out, oxe, post and rails, and gates. At management's discretion, a dotted line may be put into effect to restrict the size of the courtesy circle in hunter classes.

NCHJA FOLLOWS ZONE 3 RULES

RIBBONS/TROPHIES/CHAMPIONSHIPS: All hunter classes receive eight ribbons unless otherwise noted. All equitation classes receive six ribbons unless otherwise noted. All jumper classes receive six ribbons unless otherwise noted. Each hunter and jumper section will receive a champion & reserve award based on points unless otherwise noted. Full Championship points will be given in all classes in each hunter section except Green Conformation Hunter Model which will count as half points. In all hunter sections, Champion and Reserve Champion will be awarded to

two of the top four horses acquiring the most points over fences. These four horses will also receive full points for one under saddle class.

PRIZES: Prize money is indicated for each class. Prize money won can be paid by check or deducted from each horse's account. An IRS W-9 form must be completed in full before any prize money exceeding \$600 can be paid. Prize money will be withheld if the recipient's Social Security number is not on file. Prize money will be payable to the owner unless written authorization, and complete alternate payee information, is on file with the show secretary. All prize money will be paid within 30 days of the shows' conclusion.

GENERAL RULES AND INFORMATION

OPERATION OF MOTORIZED VEHICLES: Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

SHARPS DISPOSAL: Sharps containers will be provided in all barns for the disposal of needles and other disposable sharp instruments. ALL items of this nature MUST be disposed of in the provided containers. NO SHARPS are to be disposed of in any receptacle other than the provided sharps container. Any individual or entity not in compliance will be subject to a \$100 fine per USEF 1210.4

COMPETITION OFFICE HOURS:

COMPETITION DAYS: Office opens one hour before the start of the first class and closes 30 minutes following the last class.

DAY EXHIBITORS Horses ENTERED but not stabled at the horse show must use the designated area for day exhibitors. \$50 grounds fee will be assessed. Ship-Ins/ Day Exhibitors at Management's discretion.

SERVICE FEE All horses, showing or non-showing, will be charged a \$75 fee. This fee allows the horse UNLIMITED online add/scratches from classes, access to schooling areas and rings at designated times and defers all charges for parking passes. However, all riders must check in with the office, sign all waivers and obtain a number.

SPLITTING OF TACK STALLS: The Horse Show Office will be happy to split the tack stalls per the trainer's instructions among his/her customers up to Friday at 3:00 pm. At that point, the total amount will be billed to the trainer's barn account.

SCHOOLING: Schooling in the show rings without permission is prohibited at all times. This includes riding, exercising and lunging. A \$100 fine will be assessed for anyone caught in the rings before or after the show without permission and will be eliminated from the competition.

FEED & BEDDING: In order to assure exhibitors of an adequate supply of feed, hay, and bedding based on fair market prices, no feed vendor other than NCHJA will be permitted on the grounds without the express permission of management. For same day delivery, feed orders must be received prior to 11:00 a.m. For hay and bedding reservations prior to arrival, please go to Stable Master website at www.stallinfo.net.

MINOR EXHIBITORS: Parent(s) and guardians of minor exhibitors shall hold the horse show management and facility harmless for any injury to such minor. No child's entry will be accepted or number issued unless entry is signed by parent or LEGAL guardian. No exceptions.

PARKING: Fire regulations prohibit all vehicles, including trailers, vans and passenger vehicles from being parked in the stable areas. Vans and trailers will be allowed in the stable area only to load or off-load. **PARKING AREAS WILL BE DESIGNATED AND VIOLATORS WILL BE TOWED AWAY AT OWNER'S EXPENSE.**

PHOTOGRAPHY & VIDEO: Kirsten Hannah Photography is the official photographer of the NCHJA Annual Horse Show. Any photographers on the grounds taking photos in any capacity other than personal use are asked to check in at the

office and obtain credentials.

TICKETED SCHOOLING: If time and weather permits, management may make ticketed schooling available for \$30 per round. Back number and signed entry blank are required. Time limits may apply. Switching riders or horses, leaving and returning will be billed as a second ticket.

COMPLETE FEDERATION ENTRY AGREEMENT: By entering a Federation-licensed Competition and signing the entry as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaultor or Lunger & on behalf of myself & my principals, representatives, employees & agents, I agree that I am subject to the Bylaws & Rules of The United States Equestrian Federation, Inc. (the "Federation") and the local rules of the Competition.

I agree to be bound by the Bylaws and Rules of the Federation and of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the Competition, the Federation, their officials, directors and employees for any action taken under the Rules.

I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/or the Competition may use or assign photographs, videos, audios, cablecasts, broadcasts, internet, film, new media or other likenesses of me and my horse taken during the course of the Competition for the promotion, coverage or benefit of the Competition, sport, or the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status.

I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of Federation rules are governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State. See GR908.4.

WARNING: THE NCHJA ANNUAL HORSE SHOW, ITS MANAGEMENT, OFFICERS, OWNERS, OFFICIALS, AND EMPLOYEES WILL NOT BE RESPONSIBLE FOR ANY ACCIDENT OR LOSS WHICH MAY OCCUR TO AN EXHIBITOR, SPECTATOR, GUEST, RIDER, GROOM, ATTENDANT OR OTHER EMPLOYEE, ANIMAL, VEHICLE, OR EQUIPMENT AT THE SHOW. THIS SHALL BE A CONDITION OF ENTRY TO THE SHOW OR SHOW GROUNDS.

Show Management reserves the right to interpret all questions and conditions in regard to, or arising out of the show without claims for damages or recourse of any kind. All items not covered in these rules and information shall be decided by Horse Show Management, its' decision to be final.

RELEASE & WAIVER: I hereby fully and forever release, waive and discharge the RELEASED PARTIES and each of them who are or might be liable in any way from any and all claims, demands, actions, causes of actions, liabilities of any kind which I may or might have against RELEASED PARTIES or any of them, arising from or by reason of any and all known and unknown, foreseen or unforeseen bodily and personal injuries, damage to property, injury to horse and any consequences thereof, which I may sustain due to the ordinary negligence of RELEASED PARTIES;

I further agree that except for the gross negligence or willful misconduct of the RELEASED PARTIES, I SHALL NOT SUE or bring any legal action, claim, and/or demand against for any economic and non-economic losses due to bodily injury, death, property damage and/or injury to any horse in relation to the SHOW GROUND FACILITIES and/or the operation and conduct of the COMPETITION. I agree this RELEASE INCLUDES ALL ACTIVITIES I PARTICIPATE IN AND ALL AREAS OF THE SHOW GROUND FACILITIES as defined above. This release also includes all activities I conduct at the SHOW GROUND FACILITIES and includes all times that I am at the SHOW GROUND FACILITIES no matter what the purpose and/or activity being undertaken.

HOLD HARMLESS: I hereby agree to defend, indemnify and hold harmless RELEASED PARTIES from and against any and all claims, liabilities, loss, damages, demands, actions, causes of action, including attorneys' fees, cost and expenses of any kind, which may be made against them, or any of them, which arise out of the active or passive negligence of RELEASED PARTIES while either I or any horse at my request or in my control is/was on the SHOW GROUND FACILITIES and/or participating in the COMPETITION. I agree to defend RELEASED PARTIES, at my expense, regardless if RELEASED PARTIES are negligent or not.

ASSUMPTION OF RISK: I hereby acknowledge and assume the risk that equestrian activity, including jumping, is very dangerous and involves the risk of serious injury and/or death and/or property damage. I expressly acknowledge that injuries may be compounded or increased by negligent maintenance of the SHOW GROUND FACILITIES, faulty or improperly secured equipment, improper supervision or compliance with Federation rules and regulations. Acts of God and negligent rescue operations or procedures of RELEASED PARTIES and negligent handling of horses and independent operations by trainers, riders and/or boarders

who use the SHOW GROUND FACILITIES or others who are not affiliated with RELEASED PARTIES. I acknowledge that horses can be injured while being ridden, groomed, stabled, walked and/or exercised and I expressly assume the risk of injury to any horse under my control and/or custody or on the SHOW GROUND FACILITIES at my request.

This agreement shall be governed by the laws of the State of North Carolina with respect to all RELEASED PARTIES, except for the Federation as set forth on page one. I agree this Release extends to all acts of ordinary negligence of RELEASED PARTIES and is intended to be as broad and inclusive as permitted by law. If any portion of this Release and/or Entry Blank is held invalid, it is agreed that the balance shall continue in full legal force and effect. I have not relied on any oral representations or statements made that are contrary to or modify the above Release or warnings.

I agree that by signing the front page of this Entry Blank that I am bound by the Release, waiver and warnings contained herein and that both sides/pages constitute one incorporated agreement. I agree I have the express authority to sign this entry blank/Release on behalf of the owner and/or rider.

WHILE EVERY EFFORT HAS BEEN MADE TO AVOID MISTAKES IN THIS PUBLICATION, THE HORSE SHOW MANAGEMENT, PARTNERS, AND STAFF ASSUME NO LIABILITY FOR ERRORS. SIGNIFICANT ERRORS OR CHANGES WILL BE DISCLOSED TO EXHIBITORS WHOSE ENTRIES ARE ACCEPTED, UPON THEIR ACCEPTANCE; AND OTHERWISE IN ACCORDANCE WITH USEF RULES.

2025 BIOSECURITY PROTOCOLS

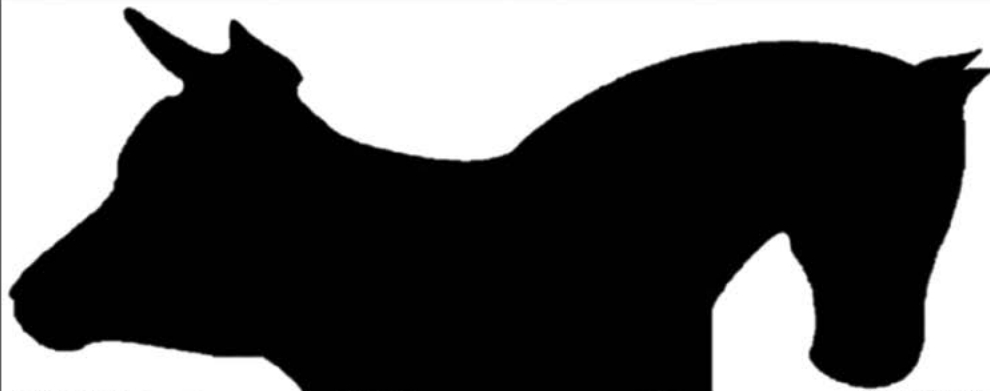
The NCHJA is dedicated to the health, welfare and safety of all exhibitors both equine and human. To protect our equine partners, we will be enforcing the following protocols at The NCHJA Annual Horse Show 2025.

1. A current (within 12 months) negative Coggins test is required.
2. Any horse on the show grounds with a fever of unknown origin or of suspicious origin must be reported to Show Management and to the Show Veterinarian. Isolation stalls will either be available on the grounds or at a local veterinary practice if the need arises.
3. Please take the time to review good equine hygiene practices. Please convey the importance of this to your equine caretakers for their daily routines.
4. USEF GR845 Equine Vaccination Rule
5. At Federation licensed competitions horses, more than 7 months of age, entering the grounds must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) vaccinations within six months prior to entering the stables.

Horses not in compliance with this rule may be required to leave the competition grounds upon request by Competition Management. Documentation should consist of one of the following methods mentioned below. The frequency of vaccine administration should be per the vaccine manufacturers' or veterinarian's recommendations. It is recommended that vaccines are administered by or under the direction of a veterinarian.

6. In the case of vaccines administered by a veterinarian, the exhibitor, upon request by Competition Management, must provide documentation from the veterinarian on documenting that the horse in question received the vaccinations; name of the vaccines and date of vaccine administration.
7. In the case of vaccines administered by a person other than a veterinarian, the exhibitor, upon request by Competition Management, must provide a receipt of the vaccine purchase which is signed by the owner, or agent with care, custody, and control of the horse; name, serial number and expiration date of the vaccine; and date of vaccine administration.
8. In the case of a horse that is unable to receive either of the vaccinations due to a history of adverse reactions, the exhibitor, upon request by Competition Management, must provide a letter from the veterinarian on official letterhead stating that the horse in question cannot be vaccinated due to medical concerns and a log of temperatures taken twice daily for the seven days prior to entering the competition grounds. These horses must also have their temperature taken and logged twice daily while on the competition grounds. The log of temperatures should be provided to the Competition Management, steward, or technical delegate when requested.
9. Competition Management may not amend or enhance vaccination requirements without prior approval of the Veterinary Committee.

For and in consideration of United States Equestrian Federation, Inc. dba US Equestrian ("USEF") allowing me, the undersigned, to participate in any capacity (including as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, official, trainer or volunteer) in a USEF sanctioned, licensed or approved event or activity, including but not limited to equestrian clinics, practices, shows, competitions and related or incidental activities and _____ ("USEF Event" or "USEF Events"); I, for myself, and on behalf of my spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors, and assigns, hereby agree to and make the following contractual representations pursuant to this Agreement (the "Agreement"):

A. RULES AND REGULATIONS: I hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at www.usef.org, as amended from time to time.

B. ACKNOWLEDGMENT OF RISK: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any USEF Event involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the USEF Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent, at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) assistant handlers in Dressage Sport Horse Breeding classes.
